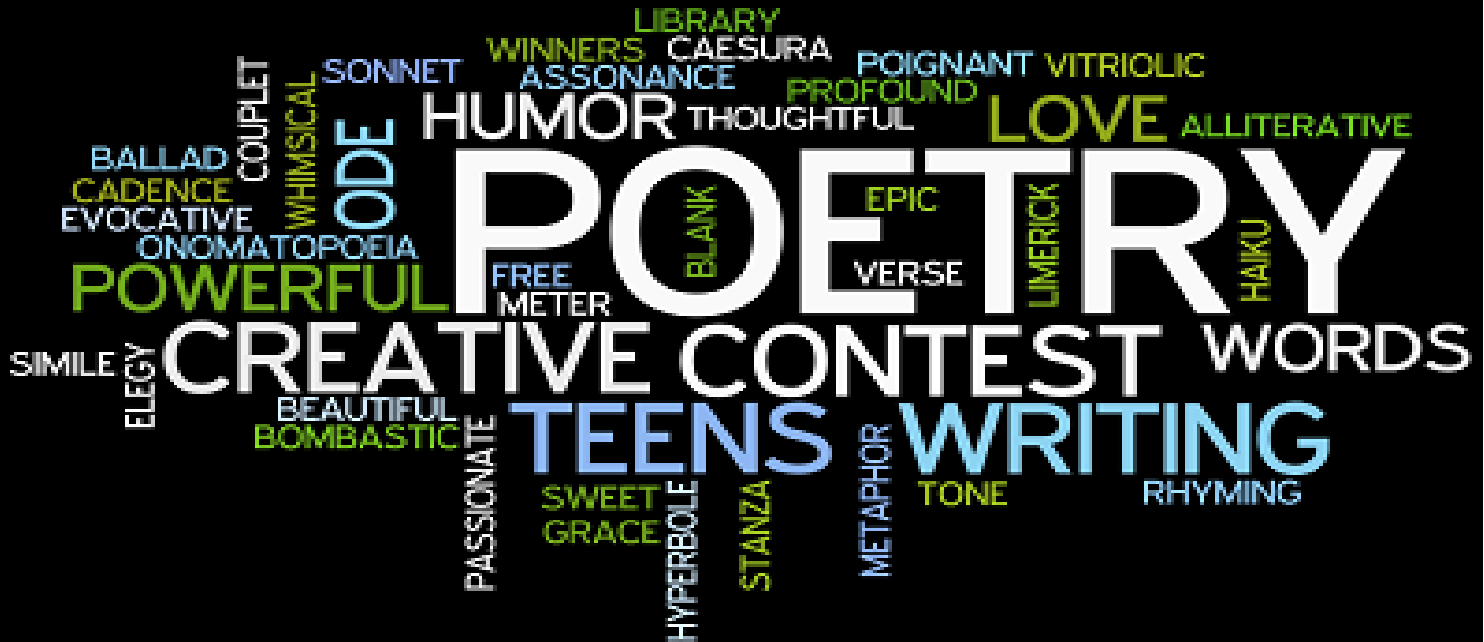

**RELEASE, WAIVER, COVENANT NOT TO SUE, INDEMNITY AND
ASSUMPTION OF RISK AGREEMENT; AGREEMENT TO USE
LIKENESS OR IMAGE**

(EXHIBITION)

Please Read Carefully

In consideration of Indian River County allowing the undersigned to display or exhibit one or more items of personal property in buildings or on property owned by Indian River County (the "Exhibition"), the undersigned, after carefully reading and understanding this agreement, hereby knowingly and voluntarily (a) releases, satisfies and discharges Indian River County, including its commissioners, officers, employees and agents (collectively the "County") from any and all claims, causes of action, losses, damages, expenses or liabilities of any type whatsoever, arising out of any personal injury, death, property damage or property theft occurring during the course of, or relating in any way to, the Exhibition (collectively "Claims"), (b) irrevocably waives all Claims, (c) agrees that the County shall have no liability with respect to any Claims, and agrees not to sue the County with respect to any Claims, (d) agrees to defend, hold harmless and indemnify the County with respect to any Claims, including reasonable attorneys fees, (e) acknowledges and assumes all risk of personal injury, death, property damage or property theft occurring during the course of, or relating in any way to, the Exhibition, and (f) acknowledges and agrees that sections (a), (b), (c), (d) and (e) above shall apply to any Claims accruing or arising at any time after the date of this agreement through completion of the last and final event relating in any way to the Exhibition, and shall apply to any Claim based, in whole or in part, upon any negligence by the County.

In addition to the above, I agree that the County may use and publish any photographs, video or digital images of me and/or the items of personal property in any media (e.g., print, television, etc) for the purpose of advertising or promoting the County generally, or the Exhibition.

This agreement has been signed by the undersigned on behalf of himself/herself, and shall be binding upon the undersigned and the personal representative or heirs of the undersigned. If the undersigned has signed this agreement as an officer or agent of an organization, the agreement shall be binding upon the undersigned individually and the organization.
